SIRC 2015 to be star studded with Keynote by CEO of AXIS Capital

Mr Albert Benchimol, Chief Executive Officer of AXIS Capital and named CEO of the combined company of AXIS Capital and Partner Re*, will be the industry keynote speaker at the 13th Singapore International Reinsurance Conference (SIRC), to be held from 2nd to 4th November at the Marina Bay Sands, Singapore with the theme “Managing Risks in an Uncertain World”, while Ms Jacqueline Loh, Deputy Managing Director, Monetary Authority of Singapore, will deliver the official keynote address.

The Executive High Level Panel on “Managing Risks in an Uncertain World” which follows the opening ceremony on 3rd November, will be led by Mr Benchimol, and will also include industry heavyweights like Dr Ludger Arnoldussen (Board Member, Munich Re); Mr John Dacey (Member of Group Executive Committee, Group Chief Strategy Officer and, Chairman Admin Re®, Swiss Re); Mr Amer Ahmed (CEO, Allianz Re); Mr Eric Andersen (CEO, Aon Benfield); Mr Emmanuel Clarke, (CEO Global, Partner Re); and Mr Vincent Vandendael (Lloyd’s Director of Global Markets). The other plenary session will deliberate on the topic “Changing Regulatory Landscape – How will Reinsurers Respond?”.

The four satellite sessions on 4th November include “Does Size Matter in Reinsurance?”; “Innovating Reinsurance Solutions for the Changing Asian market”; “Impact of the ASEAN Economic Community on the Insurance Industry”; and “Rising Nat Cats in Asia: Managing Emerging Risks and Blind Spots”.

The SIRC – which has already entrenched its position as the Monte Carlo of Asia – will be held annually from 2017, and will contemplate the disruptive trends within and outside the reinsurance industry while offering extensive platforms for intensive bilateral networking sessions over three full days. It is the premier reinsurance event in Asia, drawing key decision-makers and senior management executives within the insurance, reinsurance, broking and regulatory communities. Previously, the 12th SIRC hosted some 940 delegates from 49 countries all over the world.

The 13th biennial run of the Conference is organised by the Singapore Reinsurers’ Association (SRA), together with the Reinsurance Brokers’ Association of Singapore (RBAS) and the Singapore College of Insurance (SCI), with *Asia Insurance Review* as its official media partner.
