THE SINGAPORE REINSURERS' ASSOCIATION HOLDS IN-PERSON ANNUAL GENERAL MEETING AND ANNOUNCES NEW EXECUTIVE COMMITTEE LINE-UP FOR 2022-2023 TERM

Wednesday, 1 June 2022 – For the first time in three years, the Singapore Reinsurers' Association (SRA) held an in-person Annual General Meeting (AGM) on 20 May, with 17 Ordinary members represented, including two by proxy. Apart from the usual resolutions that were passed at the AGM, the members were also updated on plans to diversify the Association's revenue streams as well as the upcoming 18th Singapore International Reinsurance Conference (SIRC), which will be held in hybrid format, with the conference, meetings and networking segments conducted in-person as was the case in 2019, as well as a scaled-down virtual segment to enable those unable to travel to Singapore to access the conference sessions and other content on the virtual platform. By the end of the AGM, a new 10-member Executive Committee (EXCO) was unveiled for the 2022-2023 term, comprising a mix of standing, re-elected and freshly elected members.

Following the AGM, the EXCO hosted a Members' Luncheon, its first in-person social event since the COVID-19 lockdown in April 2020, which was attended by about 50 representatives from 25 Ordinary and Associate members as well as members of the SRA's Sub-Committees.

SRA Chair, Mr Haushofer remarked: "I am very pleased with the turnout and active engagement with members at this morning's AGM as well as at the Members' Luncheon. It is very clear that everyone welcomed the opportunity for "face-to-face" interaction once again. I believe that the upcoming 18th SIRC will also be well supported given the very positive feedback that we have received thus far.

Through an electronic poll conducted after the AGM, the EXCO members confirmed the re-appointment of Mr Marc Haushofer, Chief Executive Officer, Asia Pacific & Executive Vice President of Validus Reinsurance Company as SRA Chairman; Mr Kenrick Law, Regional CEO & Head P&C Client Management (incl Agriculture) of Allianz SE Reinsurance Branch Asia Pacific as Deputy Chairman; Mr Richard Lim, Chief Executive of China Reinsurance (Group) Corporation Singapore Branch as Honorary Secretary; and Ms Ann Chua, Head of Asia, Reinsurance for Catlin Re Switzerland Ltd Singapore Branch as Honorary Treasurer.
